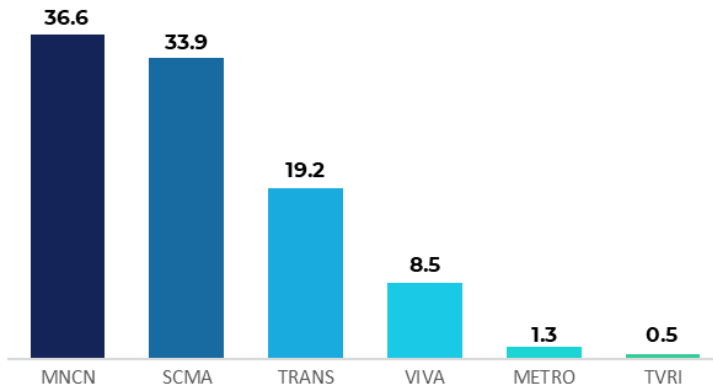

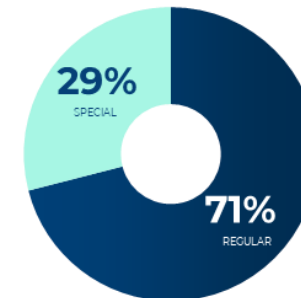

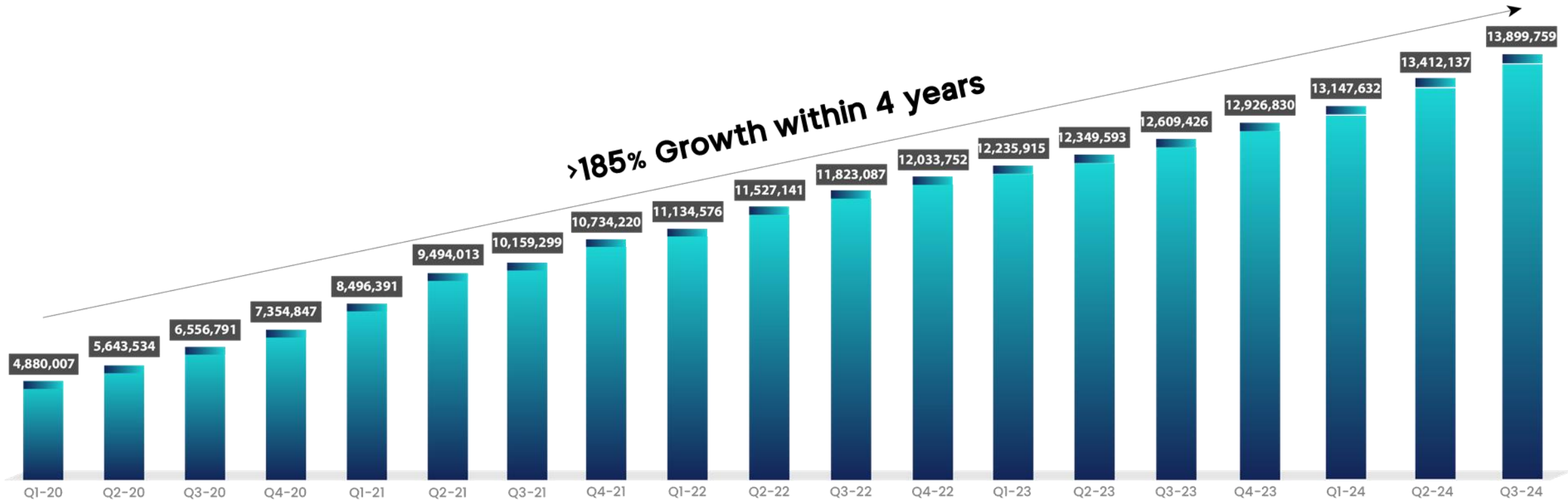
AD SPEND SHARE BY MEDIA GROUP

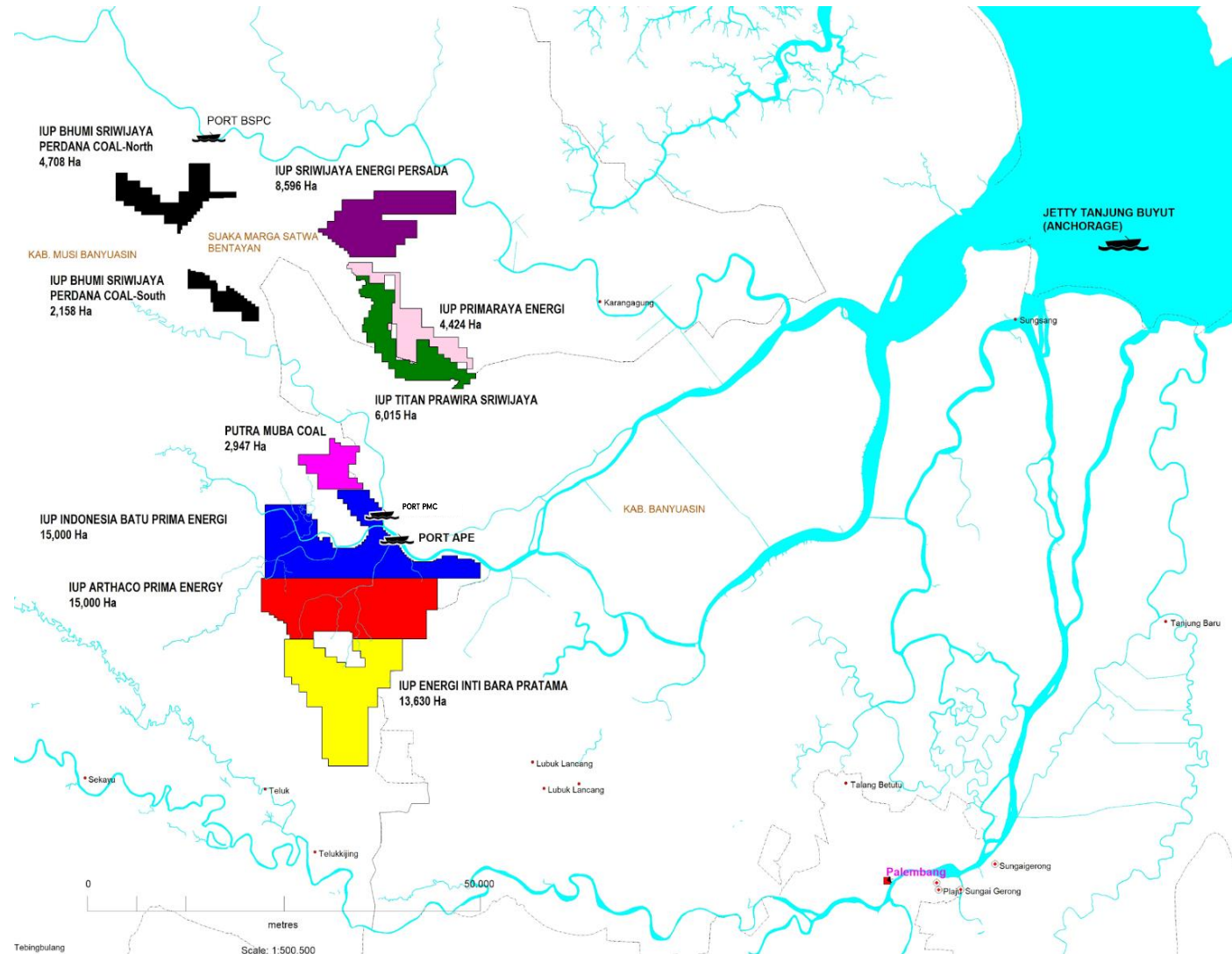

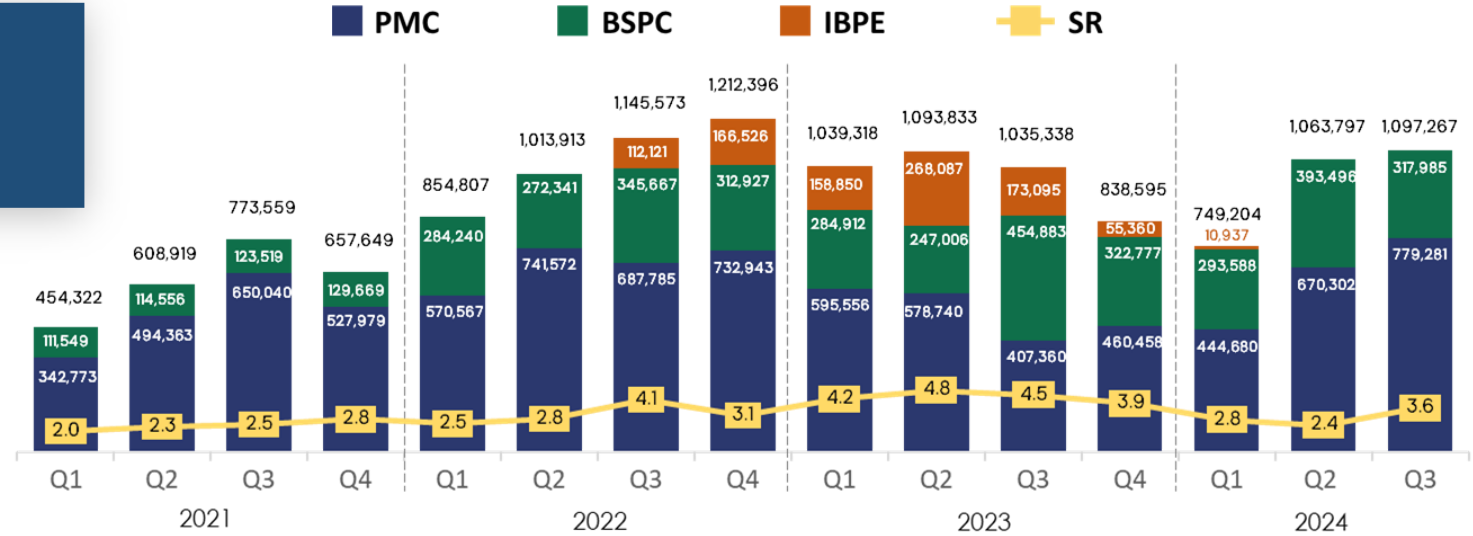

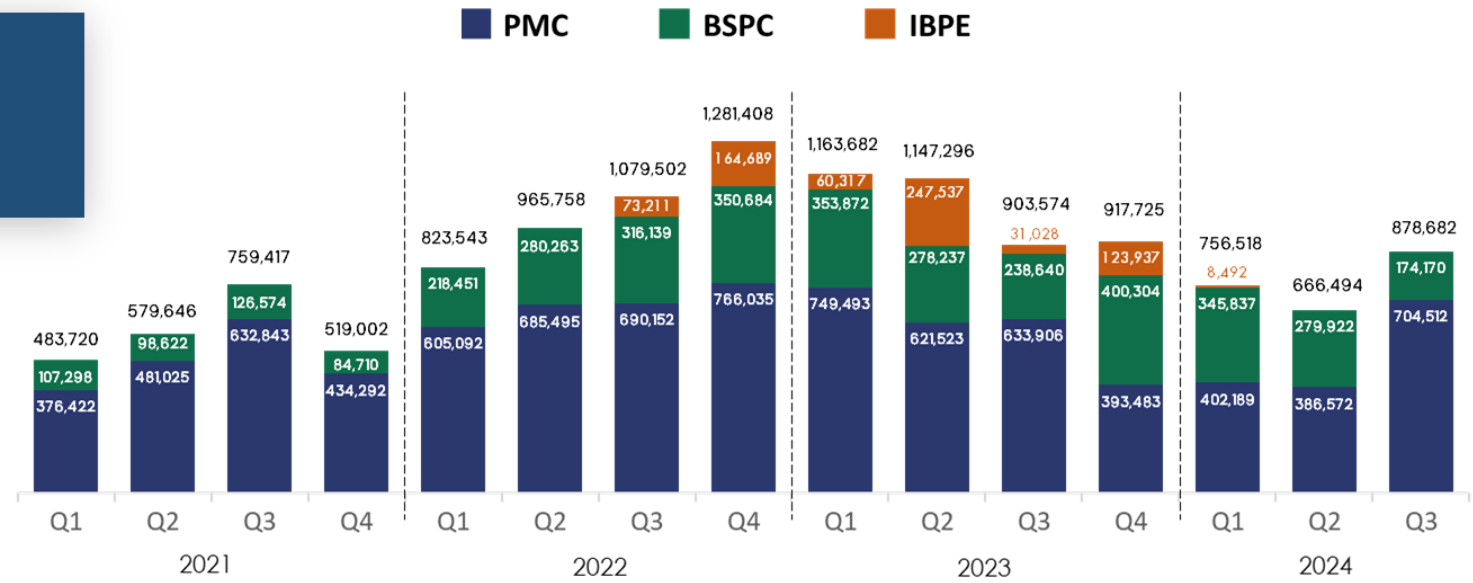
